All payments may be wired or paid by cheque, but call us first if you wish to wire the money. Please make all cheques payable to Calvin Christian School. A receipt will be issued. No tax receipts will be issued.

Dear Friends,

Thank you for your interest in Calvin Christian School. We are pleased to explain our tuition and fee form with you. Calvin Christian School offers a wide variety of programs and activities for the students at a very low tuition fee of \$8400 per family or \$4700 for kindergarten only.

The tuition and fee form may appear a little confusing at the outset, however, we wish to emphasize that the minimum full time family tuition at Calvin Christian School is \$8400.

The \$8400 figure is determined by taking our operating budget and dividing it by the number of families with children enrolled at Calvin Christian School. Then we subtract the amount that fund raising and volunteering activities raise. This year, we estimate that general fund raising activities to support our operating budget save each full time family about \$400 (\$200 for SK only) in tuition. In other words, the full tuition would be about \$400 more (\$8800) without the contributions of fund raising and volunteering efforts.

You are invited to reflect on your possible participation in terms of fund raising and volunteer activities. You can help raise funds for the school by attending our bazaar, attending our pancake breakfast, volunteering at different school functions or by participating in our golf tournament.

You are invited to claim up to full \$400 as a reduction from \$8800, resulting in the \$8400 tuition fee, or you may claim no reduction at all, resulting in a \$8800 tuition fee. What you decide to do is completely up to you; we will not ask any questions about your decision.

Finally, for those of you who will also be enrolling children into Hamilton District Christian High School, you may claim a reduction from \$1 up to \$1000. Here too, we invite you to determine what you can afford to do.
