Program Rules and Guidelines

- ❖ Your account number must appear on all orders submitted to ensure your purchases are accurately recorded. Certificates may also be purchased directly from the office.
- ❖ Payment is to accompany the order. Cheques are accepted and should be made payable to Calvin Christian School TRIP. These payments are not tax deductible.
- ❖ NSF cheques will be charged a \$20.00 fee payable to Calvin Christian School TRIP. Your privileges may then be limited to cash only.
- ❖ Certificates are purchased on your behalf and are not returnable.
- ❖ When you receive your certificates, please verify and report any discrepancies within 24 hours. Please contact Nancy Rumph at 905-388-2645.
- ❖ Certificates are the same as cash and should be handled accordingly. Calvin Christian School will not be responsible for certificates that are lost, stolen or misplaced while in your possession.
- ❖ You must sign a Waiver of Responsibility form. Certificates will only be released to a third party once the form is received in the office.
- ❖ Once per year, Calvin Christian School will provide a summary of each participating family's purchases. Just fill in the appropriate box/information and forward to the office to the attention of the Finance Manager.

Tuition Reduction Incentive Program (TRIP)

Calvin Christian School, Hamilton (CCS) is pleased to offer you an exciting opportunity to reduce tuition obligations. Since you already shop at many of the participating merchants, why not enroll in TRIP and reduce your (or someone else's) tuition cost at the same time?

CCS is able to purchase bulk quantities of gift certificates at a discount. The certificates are then sold at face value and 50% of the discount received is passed on in the form of tuition reduction.

Registrants may direct tuition credits earned to their own personal account, the account of another family, or to the CCS Tuition Assistance Fund, which provides need-based financial aid awards to current families.

Young families, who intend on sending their children to CCS in the future, are encouraged to join the program as well, however, participation in the TRIP program does not guarantee placement of the child when it is time for enrolment. Normal admission procedures and policies will still be followed. TRIP certificates are transferable to any Christian School affiliated with the Ontario Alliance of Christian Schools (OACS).

TRIP participants may also place orders for relatives or friends. Family and friends may register their own TRIP account and designate credits to another family or families.

Discounts vary, so the amount of tuition credit received will also vary.
